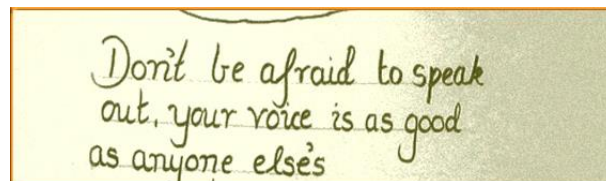

This spring a most interesting and challenging Erasmus+ project - the "I am a Sport Entrepreneur - What R U" project was granted and the project will be kicked off in June. The project will experiment with new ways of making young people, including young people with less future opportunities, interested in creating entrepreneurial sport actions, offering them a lot of useful capacity building along with substantial social and economic perspectives.

### # NEET U: mentor or broker? #

The 2½ years long Erasmus+ project "NEET U" is now on its way to start its practical experimentation in a number of EU communities. The idea is to use experienced seniors as NEET "brokers" to build capacity among NEET youth to change their dead-end situations and to create something useful for themselves.
